Dear Valued Customer,

On January 8, you were issued notification that Taro Pharmaceuticals U.S.A., Inc. initiated a Voluntary Recall for three (3) lots of Nortriptyline HCl Capsules USP, 10 mg, 100 count bottles (NDC 51672-4001-1) listed in the table above, which were manufactured by Taro Pharmaceuticals for distribution under the Taro label.

This follow-up letter is to notify you that the Food and Drug Administration reviewed our recall strategy and recommended that this recall should be <u>extended to the RETAIL LEVEL</u>. We request that you provide notification to any intermediate distributors and retail customers to whom you may have distributed lots AC05096, AC05098 and AC05099, and instruct them to examine their stock <u>immediately</u> to determine if they have any units from these 3 lots on hand.

If they do, <u>please request that they discontinue sales of Nortriptyline HCl Capsules USP, 10 mg, 100 count bottles, Lots AC05096, AC05098 and AC05099</u> and instruct them to promptly return all units to you or to our distribution center. All returned units of Lots AC05096, AC05098 and AC05099 should be forwarded to the Taro distribution center at:

As you were previously informed, Nortriptyline HCl Capsules USP, 10 mg, 100 count bottles, Lots AC05096, AC05098 and AC05099 are being recalled because the quantity of active ingredient used for these product lots was inadvertently taken from an ingredient lot from an alternate supplier before that specific lot was formally qualified for use by the manufacturing site. Please be assured that this raw material lot was fully tested prior to its use and complied with all the established ingredient specifications. There are no health or safety risks associated with the continued use of Lots AC05096, AC05098 and AC05099, as both the active raw material and the product lots were fully tested and released after passing all quality specifications. Taro is recalling Lots AC05096, AC05098 and AC05099 as a precautionary measure and to remain compliant with current GMP practices. This recall is being conducted with the knowledge of the Food and Drug Administration.
